#### Semdom 1.6

#### Release Notes v 1.1

#### <u>Content</u>

This text describes the required changes to <u>semdom 1.5.c</u> in order to make it consistent with the "coding manual 1.6" (nl, fr).

These changes have been defined and approved by the "voluntary sectorial working group" that supports the semdom model and that is open to anyone who wants to join.

#### **Underlying principles**

## Changes implied by the "coding manual 1.6":

We have applied the following underlying principles when defining the changes.

- Minimal modifications to semdom 1.5.c
- Maximal consistency over the different items in the model
- Maximal simplifications

## Changes said to be "bug fixes":

Based on community feedback, we have fixed some manifest "bugs" in the semdom 1.5.c.

## Changes implied by the "promotion of attributes":

We have added the hardcoded attributes of acts as aspects of these acts.

- It concerns the attributes : StatusId, BySubjectId, PlanningTypeId, ActPlanningTypeId, PlanningDateTime, PlannedExecutionStartDateTime,
  EffectiveExecutionDurationTimeSpan, RecipientOfCare, ProtocolCode, ProtocolName, ContextActSys, ContextActRef (see <u>xml message format</u>; for a description see: <u>nl/fr</u>)
- We have defined the corresponding aspect for attribute "x" as "\_x". E.g. the aspect that corresponds to attribute "EffectiveExecutionDurationTimeSpan" has AspectCode = "\_EffectiveExecutionDurationTimeSpan".
- We only have defined those aspects if they are required for the calculation of items that depend on that item.

As far as the calculation of scores is concerned:

- The calculation is now to be based on the presence of the corresponding aspects and no longer on the promoted attributes.
- However, we add the following rule: "if the corresponding aspect is not explicit present, but the promoted attribute is present, we implicitly assume that the corresponding aspect is present and contains the value of the promoted attribute".
- This rule guarantees that the system is backwards compatible. The XML files that contain acts need not change.

This modification not only simplifies the generation of the XML files, but also makes the semdom more readable.

- The section Attributen / Attributs (shown below in yellow) is no longer necessary, except for one condition concerning facts.

## Changes to the XML file format

The notion of plans has been updated to the description of the coding guide 1.6.

We now distinguish between the following concepts that each are considered a variant of the notion of "plan", called "Plan Kind":

- CP: care plan, not further distinguished between ECP, ICP, SCP. Its usage is deprecated.
- SO standing order

- ECP: a care plan in the context of patient education
- ICP: an individual care plan
- SCP: a standard care plan
- MP9: a recurring medical prescription
- MP1: a medical prescription "once"

We have avoided to make a breaking change to the XML file format (and thus also to change the associated xml name space). Therefore:

- <PlanKindId> of <Plan> remains optional. If absent, CP is assumed.
- <PlanKindId> can still hold the previous values CP, SO. Additionally, it can now also hold ECP, ICP, SCP, MP9, MP1.

The new xsd schema is defined in the single file <u>rimvg2v3b.xsd</u>, replacing the earlier files <u>rimvg2v3.xsd</u> and <u>rimv2v3Types.xsd</u>.

The list of valid plan kinds of a plan is now listed in square brackets after the name of the plan.
